**RE: COVID 19 VACCINES**

1. We act for Generational Health and Wellness Institute and a number of other groups and individuals in South Africa who are concerned with the lack of reliable information regarding the different Covid 19 vaccines that are intended to be administered to the general public of South Africa.
2. We have noted that you are conducting a number of Covid 19 vaccine trials in order to assess the safety of the vaccines in healthy individuals.
3. In order to allay the concerns and fears that our clients have regarding these vaccines, we require that you assist us by answering the questions which follow.

**Ingredients**

1. What are the ingredients of the different Covid 19 vaccines intended to be administered to the South African public?
2. If any of the following ingredients are contained in these vaccines, what is the purpose of each ingredient?
  - 2.1. Hexane;
  - 2.2. Aluminium;
  - 2.3. Mercury;
  - 2.4. Thimerosal;
  - 2.5. Formaldehyde;
  - 2.6. Synthetic Genes;
  - 2.7. Aborted human foetal cells;
  - 2.8. Potassium chloride;

- 2.9. Glyphosate;
- 2.10. Beta – HCG;
- 2.11. Luciferase.

### **Mechanism of developing immunity**

- 3. Has the Sars-CoV2 been isolated/purified and its complete genome sequenced? If not, how is it possible to have developed a vaccine for the virus without isolating or purifying the virus?
- 4. What is the exact mechanism of action of each Covid 19 vaccine in developing immunity?
- 5. Is there an intention to use a nanotechnology device called the hydrogel biosensor (or any other) which can be injected and implanted under the skin using a vaccine as the delivery system?
- 6. Is there any truth in the reports that the hydrogel biosensor would effectively merge with the body and would transmit biometric and body activity to a central server?

16. What mechanism has been established to stop the mRNA process once the immunity has been achieved?
17. If there is no mechanism to stop the mRNA process, is this not creating a significant risk for the development of autoimmune disease?

#### **Safety of the vaccine**

18. A vaccine usually takes 10 to 15 years to develop. The Covid-19 mRNA vaccine is being brought to market in a matter of months. Have proper safety studies been done on the vaccine including its potential short and long-term harmful effects?
19. Is the Covid-19 vaccine designed and intended to modify the human genome?
20. Are adverse effects anticipated with the Covid 19 vaccines?
21. The Novovax Covid 19 trial requires the participants to remain on the trial for approximately one year. Will the vaccine from this trial only be available to the public after completion of the trial at approximately a year?

### **Target population for the administration of the vaccine**

22. Will the vaccine be recommended to be administered to the 850,000+ persons who have previously tested positive for Covid 19?
23. Is the vaccine aimed at preventing the severe form or the mild form of Covid 19?
24. What is the rationale for recommending vaccination to the entire population when only a select few are at risk of developing the severe form of Covid 19?
25. Is the intention to supply and administer vaccines to the general population or are the vaccines only to be administered to those who are at risk from developing the serious form of disease?
26. Is the administration of the Covid 19 vaccine intended to result in lasting immunity?
27. Over 99% of persons exposed to the Covid 19 virus will have a mild form of disease. Does the fact that less than 1 percent of those exposed to the virus who go on to develop a severe form of the disease warrant implementing this speedily tested and new technology in the fight against Covid 19?
28. Is there an intention for the vaccine to track and trace? Is there intention to use microneedle tattoo patches or quantum dot tattoo patches to administer the vaccine?
29. On 3 June 2020 Microsoft filed patent W02020060606 - CRYPTO CURRENCY SYSTEM USING BODY ACTIVITY DATA. Are the Covid 19 vaccines associated with the system?
