- I am an adult male, born on 12th November 1961 and am a medical doctor (MB ChB obtained from the University of Natal Medical School) and business graduate (Master of Business Administration obtained from the Graduate School of Business, University of Cape Town). I also hold a Certificate in Emotional Freedom Technique (EFT obtained through the EFT Certification of Completion Program) and am the founder and director of the Health Wellness Performance Institute.
- Over the years I have done extensive research in various fields and am qualified to speak on matters pertaining to my qualifications and other matters seemingly not related to my qualifications. (See Profile here)
- 3. I was requested by Ricardo Maarman, applicant in Case No. 5852/2021 to produce this affidavit for this matter.
- 4. When the Covid-19 pandemic was announced last year, I immediately embarked on a research quest to determine the veracity of what was being propagated by government and mainstream sources, specifically that a virus called Sars-CoV2 was causing a condition called Covid-19.
- 5. My research findings have led me to conclude that Covid-19 is not a real pandemic but is in fact a deception. I presented my research findings to a number of audiences in four provinces of the Republic of South Africa during the latter half of last year (2020) and first month of this year (2021).

- 6. The title of my presentation is 'The Covid-19 Deception A Major Strategic Move Towards the Technocratic, Transhumanist New World Order'
- 7. It is my view that Covid-19 is a planned 'pandemic', the purpose of which is to implement various measures to usher in what is known as the New World Order. This has now been rebranded as the Great Reset, everything of which pertaining to it has been meticulously explained on the website of the World Economic Forum
- 8. My conclusion is based on the following facts:
 - There is no irrefutable evidence for the existence of Sars-CoV2, the virus said to be the cause of Covid-19. No one has ever isolated this virus and sequenced its genome. There are however many fraudulent claims made in this regard.
 - The Invalidity of all three methods used to diagnose Covid-19 viz. symptoms, the RT-PCR test and Antibody tests. The symptoms experienced by Covid-19 patients are not unique to this condition. The RT-PCR test is invalid and scientifically meaningless in the diagnosis of Covid-19. The inventor of this technique categorically stated that it is not a diagnostic test and hence should not be used to diagnose any condition. And finally, there are no specific monoclonal antibodies to the coronavirus.
 - Studies show a correlation between outbreaks of the condition called Covid-19 and the deployment of 5G networks.
 - Besides Electromagnetic Radiation, there are other root causes which can explain the symptoms, signs and conditions seen in patients diagnosed with Covid-19.
 - The evidence is irrefutable that Covid-19 is a planned pandemic orchestrated to usher in the Technocratic, Transhumanist New World Order the purpose of which is to enslave and depopulate humanity.
- 9. One of the primary purposes of the Covid-19 'pandemic' is to vaccinate the majority of the global population as part of the technocratic, transhumanist agenda i.e. to vaccinate those who are not a part of the small group of people known as the globalists.

- 10. In January this year I published an open letter explaining why the rollout of the Covid-19 experimental vaccination program must be stopped. In the short span of a few months the covid injections have killed tens of thousands of people and injured hundreds of thousands according to the Vaccine Adverse Events Reporting System (VAERS) in the US and other similar reporting systems in other parts of the world. This letter is attached herewith.
- 11. The lockdown measures implemented by government (social distancing, wearing of facemasks and other measures) are extremely harmful to the holistic health and wellness of the population physical, psychological, sociological and spiritual health and wellness. Studies prove that wearing face masks offer little benefit outside of the operating theatre and can be detrimental to health and wellness. There is in fact no science supporting the wearing of face masks to prevent infection. Since the virus has not been proven to exist it is illogical to practice social distancing. Human beings are inherently social beings and maintaining physical distance from each other is psychological harmful.
- 12. The impact of the lockdown on the South African economy has been devastating as explained on the website of the Department of Statistics of the South African government. It states the following: 'Steep slump in GDP as COVID-19 takes its toll on the economy *The punch in the gut was severe. Perhaps the second quarter of 2020 will become known as the pandemic quarter. South Africa's economy suffered a significant contraction during April, May and June, when the country operated under widespread lockdown restrictions in response to COVID-19.*'
