INTRODUCTION: THE JUSTICE SYSTEM IS CORRUPT: COMPROMISED: AND CENTRALLY CONTROLLED: IN 2023!

- 1. South Africa has a corrupt and inept parliament of 400 and there is no justice in this present judiciary!
- 2. There is no separation of powers between the Executive, the Legislature; and a Judiciary in our country.
- 3. There is only cadre deployment and the R1 billion State Capture Commission of 2018 has failed as well.
- 4. South Africa has an Anti-Corruption Tribunal of 2019; and that has not prosecuted the guilty in 4 years!
- 5. There is also a third Anti-corruption Advisory Council established in 2021 by the Office of this President.
- 6. There is only a situation where all justice has been delayed or totally denied and there must be JUSTICE!
- 7. South Africa has an option of ignoring the crimes against humanity and treason or bringing Judgement!

South Africa needs a Hammer of Judgement for crimes against humanity, treason, corruption - abuse of power!

- 1. South Africa has a management and leadership crisis and the parliament of 400 do not serve the people!
- 2. The Standing Committee for Public Accounts SCOPA has remained silent to all the corruption in 2023.
- 3. The Auditor General is responsible for financial accountability but has failed to control all the corruption.
- 4. South Africa has a National Prosecuting Authority but it has failed to prosecute all those public servants!
- 5. The Public Protector is responsible for protecting lives, property and human rights but has failed to do it.
- 6. A Department of Cooperative Governance and Traditional Affairs has not stopped any corruption at all.
- 7. South Africa has a Department of Justice but it has failed to prosecute public servants for all the crimes!

South Africa needs a Hammer of Judgement for Covid 19 crimes against humanity and crimes against all people!

- 1. South Africa published the Government Gazette No.19553 on the 5th of February 1999 about all crimes!
- 2. The Prevention of Organised Crime Act No 121 of 1998 is clear on the issues of organised crime in this.
- 3. It is also clear on the money laundering and criminal gang activities as well as those racketeering crimes.
- 4. South Africa published the Government Gazette No.19553 on the 5th of February 1999 about the fraud!
- 5. It is also clear on Criminal Assets Recovery Account and the Drug Trafficking Act 1992 and other matters.
- 6. The Proceeds of Crime Act 1996 and International Cooperation in Criminal Matters Act 1996 is all clear.
- 7. South Africa published the Government Gazette No. 19553 on the 5th of February 1999 about our rights!

South Africa needs a Hammer of Judgement for theft of Government Employees Pension Funds in the 29 years!

- 1. South Africa published this Gazette and it was made clear The Constitution also has that Bill of Rights!
- 2. It was made clear that organised crime presents a danger to public order and people must be protected.
- 3. It was also made clear that present justice system has failed to deal with these acts of organised crime.
- 4. South Africa has failed to deal with corruption, money laundering and racketeering organised crimes!
- It was made clear that people should not benefit from organised crime and those acts of racketeering.
- 6. It was also made clear that these acts of malfeasance are harmful to the wellbeing of an entire country!
- 7. South Africa has failed to provide the justice system that prosecutes and acts as a deterrent to crimes!









PRESENT SITUATION: THE GOVERNMENT GAZETTE NO. 19533: FAILURE TO PROSECUTE: NEED FOR JUSTICE!

- 1. The Parliament of 400 published the Government Gazette No. 19553 in 1999 but ignored the contents!
- 2. The Government Gazette contains all Definitions and Interpretations; and Offences Relating to Activities.
- 3. It contains Offences Relating to Proceeds of Unlawful Activities; and Offences Relating to Gang Activities.
- 4. The Parliament of 400 published the Government Gazette No. 19553 in 1999 but ignored all offences!
- 5. The Government Gazette contains information on the Proceeds of Unlawful Activities and all forfeitures.
- 6. It contains information on the Confiscation of Property and also details on the Asset Recovery Accounts.
- 7. The Parliament of 400 published the Government Gazette No.19553 in 1999 but ignored information!

South Africa needs a **Hammer of Judgement** for corruption which is organised crime - and crime against people!

- 1. South Africa has a corrupt and inept parliament of 400 and it is a crime against humanity and TREASON!
- 2. More than R3 trillion has been lost, wasted or stolen in less than 10 years from these people of this land.
- 3. Money has been stolen from bank accounts and pension funds; and every act of corruption is organised.
- 4. South Africa has a corrupt and inept public service as 275 municipalities are in financial distress in 2023!
- 5. More than 701 State-managed enterprises and all Organs of State are in financial distress in this country.
- 6. Money has been stolen from State Tenders; and that Supply Chain Management has not been managed.
- 7. South Africa has a corrupt and inept leadership and management and they must be prosecuted for this!

South Africa needs a **Hammer of Judgement** for crimes against humanity and all people and this is all **TREASON!**

- 1. South Africa has a parliament of 400 that have not made sure that the Justice System is totally effective!
- 2. The Justice sustem is also corrupt, compromised and is centrally controlled by an Office of the President.
- 3. The Justice system is unable to prosecute corruption; or maintain law and order or retain the rule of law.
- 4. South Africa has a parliament of 400 that have made sure the justice system protects all the ANC cadres!
- 5. The Justice system is unable to keep the peace, enforce law and order or prosecute the public servaants.
- 6. The justice system is unable to contain violence, or prevent xenophobic violence or protect lives in 2021.
- 7. South Africa has a parliament of 400 that have committed crimes or have been silent to that TREASON!

South Africa needs a Hammer of Judgement for that Kill the Boer Campaign and also The Free Zuma Campaign!

- South Africa has all the laws and infrastructure and Organs of State to prosecute but has no political will!
- 2. The country has no other option but to establish new Congress of People and remove ANC Parliament.

- 7. South Africa needs justice for Covid 19 and gene therapy experimentation and those war crimes in 2020!

South Africa needs Hammer of Judgement for Organised Crime, Racketeering, Money Laundering - or TREASON!

- 1. South Africa has a parliament of 400 that has all ignored The Government Gazette No. 19553 of 1999!
- 2. It has a parliament of 400 that has ignored the SADC Tribunal against Corruption of 2000; and the crime.
- 3. It has a parliament of 400 that has ignored the Law and Religious Communities in these SADC Countries!

PRESENT SITUATION: A SADC PROTOCOL AGAINST CORRUPTION: FAILURE TO PROSECUTE: NEED FOR JUSTICE!

- 1. The ANC/SACP/Cosatu alliance has ignored a SADC Protocol against Corruption; for more than 23 years!
- 2. In 2000 14 SADC countries agreed to sign SADC Protocol against Corruption and it was signed in August.
- 3. These included Republic of Angola, Republic of Botswana, the Democratic Republic of Congo and others.
- 4. These included Kingdom of Lesotho, Republic of Malawi, Republic of Maritius, Republic of Mozambique.
- 5. They also include Republic of Namibia, Republic of Seyschelles, Kingdom of Swaziland; and South Africa.
- 6. They include United Republic of Tanzania, Republic of Zambia and the Republic of Zimbabwe in 2000.
- 7. The ANC/SACP/Cosatu alliance signed the Protocol against Corruption and they ignored it for 23 years!

South Africa needs The Hammer of Judgement for the acts, omissions and actions taken and the silence to it all!

- The ANC/SACP/Cosatu alliance has ignored this 14 Page SADC Protocol against Corruption for 23 years!
- 2. The 14 countries in a SADC region are all battling to deal with corruption, organised crime; and treason.
- 3. They are struggling to put in place a justice system that prosecutes organised crime and racketeering.
- 4. The ANC/SACP/Cosatu alliance and parliament of 400 have no political will to prosecute public servants!
- 5. The 14 countries in a SADC region are all agonising over this plague of corruption but have no intentions.
- 6. They are even referring this to United Nationa General Assembly (UNGA) to engage as a collective effort.
- 7. The ANC/SACP/Cosatu alliance and the parliament of 400 have no intention of prosecuting their cadres!

South Africa needs The Hammer of Judgement for parliament of 400 that has failed to put an end to TREASON!

- 1. The ANC/SACP/Cosatu government has not taken cognisance of the Resolutions adopted by that SADC!
- 2. It has not taken cognisance of the Resolutions taken by these SADC leaders and all Ministers of JUSTICE.

- They were in agreement that corruption undermines good governance and principles of transparency.
- 7. The ANC/SACP/Cosatu government recognised that political will are essential ingredients in all this war!

South Africa needs The Hammer of Judgement in a war against corruption, organised crime; and the TREASON!

- The ANC/SACP/Cosatu led parliament of 400 are aware of the importance of accountability for all this!

- 6. They are certainly aware of the Authority, Transitional Provisions and Relationship with other Treaties.
- 7. The Parliament of 400 are most certainly aware of the Terms and Conditions and signed the Protocols!

South Africa needs The Hammer of Judgement for the 400 in Parliament have have delayed, or denied JUSTICE!

- 1. South Africa needs that Hammer of Judgement for a parliament of 400 that have not brought JUSTICE!
- 2. They have ignored The Government Gazette No. 19553 from 1999 until October of 2023 and 24 Years.
- 3. They have ignored The SADC Protocol against Corruption from 2 000 until October 2023 and 23 Years!

LAW AND RELIGIOUS COMMUNITIES IN AFRICA: WAR ON CORRUPTION: FAILURE TO PROSECUTE IN 29 YEARS!

- 1. The Church and Legal Practioners in South Africa have failed to curb a plague of corruption in all Africa!
- 2. On the 19th to 22nd of January 2020, a Conference was held in Durban Hotels on the Freedom of Religion.
- 3. It was held to reinforce the Vision for a Strong and United South Africa and in sub-Continent of all Africa.
- 4. The Church and Legal Fraternity in South Africa attended at the *Elangeni* and *Maharani Hotels* in 2022!
- 5. It was attended by the CRL Rights Commission; and an African Consortium for Law and Religious Studies.
- 6. It was also attended by that WARLCLARS A West African Regional Centre for Law and Religious Studies.
- 7. The Church and Legal Advocates also attended with a International Centre for Law and Religious Studies!

The Conference focused on the Role of The Church and the Law Societies and the need for Freedom of Religion!

- 1. The South African CRL Rights Commission attended for the promotion and protection of all those Rights!
- 2. These rights included Cultural, Religious and Linguistic rights and was also attended by all other groups.
- 3. It was well attended by members of the J. Reuben Clark Law School and Brigham Young U.S.A University.
- 4. The South African Department of Cooperative Governance and Traditional Affairs also attended Forum!
- 5. These interest groups attended this meeting two months before the military lockdowns in March 2020.
- 6. It was holistic and inclusive and matters arose that discussed local communities, health and the justice.
- 7. South African delegates came from the government, universties and religious and traditional leaders!

The Conference focused on Education, Social, Economic, Political and a need for Civilian Oversight Committees!

- 1. The Church and Legal Practioners came from around the world and dealt with corruption and violence!
- 2. Interfaith Panel Discussions were held on the perspectives and importance of that right to legal identity.

- 4. Plenary Sessions included A Parliamentary Key-Note and Balancing Religious Freedom Human dignity!

- 6. Plenary Sessions included Empirical Analysis of the Importance of all Religious Association Law in 2020.
- 7. Plenary Sessions included Human Rights Foundations as Comparative Perspectives; on Associate Laws!

The Conference focused on Laws: The Justice System: Bill of Rights: The Constitution and their need for JUSTICE!

- South Africa has a Humanitarian and Economic crisis and this has been created by that rising corruption!
- 2. South Africa has leadership and manangement crisis and infrastructure and service delivery is destroyed.
- 3. South Africa has Junk Status and Economic Recession and there is no socio-economic growth in our land.
- 4. South Africa has a failed Justice system and there is no separation of powers or independent judiciary!
- 5. South Africa has a corrupt, compromised and centrally controlled justice system and so is a legislature.
- 6. South Africa has Babylonian Democracy and tribalism and it needs Biblical or Decentralised Democracy.
- 7. South Africa has capable and ethical leadership and lawyers and we all need that Freedom of Religion!

South Africa needs to learn from this Conference for Freedom of Religion in Durban for that Law and Religion!

- There was no mention of all the Lonmin Mine Massacre of 2012 or Free Zuma Campaign of July in 2021.
- 6. There was no mention of the medical tyranny, Midazolim, Morphine, Remdezivir or all those respirators.
- 7. The Church, Academics and legal practioners all gathered on 19th to 22nd of January in 2020 in Durban!

South Africa needs to learn from this Conference and the need for The Hammer of Judgement for all TREASON!

- The Church and servant leaders in 2023 need to learn from The Communist Hammer created by ANC!
- 2. The Business Chambers and Captains of Industry and mind leaders in commerce must learn from this.

- 3. In 2023 there must be a Conference for Biblical Democracy and also the prosecution of those criminals!

THE FINAL PROTOCOL: THE NATIONAL PEACE COMMISSION: CONGRESS OF PEOPLE: A NEW CODESA: IN 2023!

- 1. The National Peace Commission met in Pretoria on 13th of May 2022 to discuss the State of this Nation!
- 2. The Primary Purpose and Main Aim and Objective of that meeting was to restore Peace and Freedom.
- 3. The Primary Aim and Central Objective was to restore Justice and the law and order and the rule of law.
- 4. The National Peace Commission met in Pretoria on 13th of May 2022 to discuss all different options in it!
- 5. The Central and pivotal concern is the absence of law and order and rule of law and absence of JUSTICE!
- 6. Peace is not an absence of war but rather a presence of JUSTICE and we need a Hammer of Judgement.
- 7. The National Peace Commission met in Pretoria on the 13th of May 2022 to discuss State of The Church!

The Durban Conference from 19th to 22nd of January 2020 highligted the need for a Civilian Oversight - to SCOPA!

- 1. A Parliamentary Standing Committee for Public Accounts SCOPA that has been silent to corruption!
- 2. It has been silent to the theft of Government Employee Pension Funds and the Kill the Boer Campaign.
- 3. It has been silent to their Land Reforms, 4th Industrial Revolution and a National Democratic Revolution.
- 4. Parliamentary Standing Committee for Public Accounts SCOPA has been silent to Affirmative Action!
- 5. It has been silent to all of the August 2012 Marikana Mine Massacre at Lonmin Mine London Minerals.
- 6. It has been silent to the mobilisation of the SADF for Jungle warfare in the SADC countries and the DRC.
- 7. Parliamentary Standing Committee for Public Accounts SCOPA has been silent to all this TREASON!

The Durban Conference from 19th to 22nd of January 2020 highlighted the need for Civilian Oversight – in 2023!

- 1. The National Peace Commission met with all Church and traditional and servant leaders in January 2020!
- 2. This was only two months before Covid 19 Plandemic and Genocide or a death by government decree.
- 3. This was only two months before military lockdowns, house arrest of 65 million people and GENOCIDE!
- 4. The National Peace Commission met with political and Khoi San First Nation Leadership in January 2020!
- 5. This was only 21 months before a 8 Days of killing, plundering and destruction in Free Zuma Campaign!
- 6. This was only 29 years after South Africa lost all Sovereignty in 1994 and that Codesa during that 1991.
- 7. The National Peace Commission met with academics, lawyers and religious leaders in Durban in 2020!

The Durban Conference from the 19th to 22nd of January 2020 highlighted all that need for Batho Pele Principles!

- 1. The parliament of 400 members has not dealt with that loss of Sovereignty under this ANC government!
- 2. It has also not dealt with the humanitarian crisis; and the theft of Government Employee Pension Funds.
- 3. It has certainly not dealt with all the loss of land, mining, property, water and human rights since 1994.
- 4. The parliament of 400 has also become a slave and puppet government to the slave masters in Europe!
- 5. This includes the war lords in Washington, money lords in London and also the drug lords in big Pharma.
- 6. It has also been a plague of oppression and tyrannical control; that produced a welfare and police State.
- 7. The parliament of 400 has also no defence against all that Museum of TRUTH and a Library of Evidence!

The Durban Conference from the 19th to 22nd of January 2020 simply highlighted the need for ethical leadership!

- 1. The National Peace Commission with all the South African and SADC leaders in that Durban Conference!
- 2. It was also a gathering of minds of all legal profession, government and academics from the universities.
- 3. It was also a meeting for traditional and interfaith leaders and it was focused on the freedom of religion.
- 4. The National Peace Commission is politically neutral; and was established to hold this ANC accountable!
- 5. It was a four day conference and it soon became obvious, in hindsight, that there was a political agenda.
- 6. It was also an unusual meeting when it was realised the United States and Great Britain influenced this.
- 7. The National Peace Commission was the first to challenge the Office of the President; in March of 2020!

The Durban Conference from the 19th to 22nd of January 2020 simply highlighted that need; for a new **CODESA!**

- 1. The ANC/SACP/Cosatu alliance enforced military lockdowns, house arrests; and closed entire economy!
