## Dear Advocate Mabel Jansen

The following information is respectfully provided in order to compile a written Notice to the Office of President of South Africa; the Cabinet of 28; and the parliament of 400. - 1. The National Peace Commission was established in March 2019 to be an oversight to the government!
