**PCCF INSTRUCTION 456 / 2024: SECURITY PROVISION FOR POSSIBLE NATIONWIDE UMKHONTO WESIZWE (MK) PARTY PROTEST ACTION ANTICIPATED: MAY / JUNE 2024**

- A.1. Information received indicates that possible nationwide Umkhonto Wesizwe (MK) Party protest action is anticipated to take place Nationwide during the months of May and June 2024.
- 2. The Constitutional Court of South Africa unanimously ruled that Mr Zuma is not eligible to contest the 2024 Provincial and National Elections until five years have passed following the lapse of his 15 months sentence. Members / supporters of the MK Party previously voiced intent to embark on nationwide protest action in the event that Zuma is barred from contesting the elections. However the IEC has indicated that regardless of the outcome of the ruling, Mr Zuma will appear as the representative of the MK Party on the election ballots.
- 3. Further information indicates that the risk for Intimidation, Malicious Damage to Property, Arson, Barricading of Roads, Looting, Hijacking of Trucks as well as clashes between members / supporters of the MK Party, opposing political parties and with authorities is high, should demonstrations take place.

4. The prognosis by Crime Intelligence indicates that the following areas are regarded as high-risk in the event that unrest takes place, owing to previous support for Mr Zuma:  
  
Durban Central, Springfield, Congela, Sea Cow Lake, Reservoir Hills, Bonela, Bayhead, Berea, South Beach, Umbilo, Umlazi, Umkomaas, Umgababa, Adams Mission, Umbumbulu, Blackburn, Hluhluwe, Richards Bay, KwaDukuza, Empangeni, Mooi River, KwaMashu, Verulam, Phoenix, Inanda, Ntuzuma, Ixopo, Umzimkulu, Pinetown, Amanzimtoti, Pietermaritzburg, Newcastle, Pongola, Utrech, Dannhauser, Ladysmith, Sand River Valley, Hilton, Lions River, Estcourt, Mtubatuba, Cato Ridge, Eshowe, Howick, Isipingo, Mandini, Bhobhoyi, Port Shepstone, Van Reenen, Westville, Greytown, Kokstad and Margate.
5. The District Commissioners must please ensure that the above-mentioned protest action is monitored and a Contingency Plans must be put in place to deal with any eventualities which may arise. A detailed intelligence assessment must be done so that sufficient resources can be deployed to ensure the safety and security of people attending and the general public.
