\*\*Prof Masayasu Inoue's warning about the toxic mRNA vaccines - by Dr Rapiti, April 1st, 2024, Cape Town\*\*

Prof Masayasu Inoue, an emeritus Professor in molecular pathology and medicine from Japan has made a clarion call to his government and the world to halt the use of mRNA technology, that uses viral proteins to produce vaccines.

It normally takes five to ten years to produce a vaccine after it goes through rigorous testing.
