Dear friends, colleagues and citizens in pursuit of justice for victims of the jab and human rights, our brilliant and dedicated medico-legal team for STOP THE SHOTS case, Adv Sabelo Sibanda, attorney Riekie Erasmus, (attorney/ journalist/mediator) Shabnam Palesa Mohammed, Dr Faghrie Hassen, (molecular scientist), Dr Faan Oosthuizen, the main driver behind this case and myself had a robust three hour meeting last night to iron out several pertinent issues to present our case to the court in a most effective manner with bundles of affidavits from members, treating Covid, jab injuries and a special interest in justice.

Amongst the issue that was finalised was the right type of account for this historical project for the benefit of the whole of society.

We agreed on forming an NPC which will serve the purpose of giving you, the donors, peace of mind that the funds are safe, will be used appropriately to get value for your money, every expense will be accounted for with absolute transparency, donations will be tax-deductible and finally the account will be open to anyone in a spirit of transparency.

This is a fervent appeal to all of you, who are in favour or justice being done and your constitutional rights being protected to donate to the fund, which is urgently needed to defray expenses as we fast approach our court date.

I, personally, would like to commend the entire team for

their outstanding work, compassion and ethical conduct in trying to expedite this very urgent life and death matter to stop a Jab that has not been tested, is highly toxic, with a death rate of 1200 people, according to the Pfizer documents, and which is totally ineffective against the latest but extremely safe kraken strain.

We also hope that the courts will not slap us with the costs should we lose because, to do so would be punishing you, the public and donors, for trying to seek justice. A public that is already suffering from the burden of the latest 32% hike in electricity from the bungling load-shedding Eskom.

On behalf of the committee, I wish to thank you all for steadfastly being behind our team. Your support and blessings are highly appreciated.
