## INTRODUCTION: THE ANC HAS DECLARED WAR ON THE CHURCH: ECONOMY - AND FOOD SECURITY!

- **1.** South Africa is at war and this SACP-led Government began all this war at Codesa back in 1990!

- 4. South Africa then saw Mbeki from 1999 to 2008 and he removed the Commando units in 2003.
- 5. Jacob Zuma brought the EFF: trained that militia and paid the Zulu Monarch and their leaders.
- 6. He alone and cadre deployment called for the Killing of all the Boers and the genocide began.
- 7. South Africa then saw Ramaphosa: Covid 19: and all the house arrests and military lockdowns.

The ANC declared war on The Church: the economy: and food security – and they killed those farmers!

- 1. South Africa is at war and it has led to Junk Status: Economic Recession and increased poverty.
- 2. The people were deceived by the President: 28 Cabinet Ministers and the Department of Cogta.
- 3. The Department of Cogta controlled a Covid 19 and was populated with Zuma family and Zulus.
- 4. South Africa is at war and it is led by cadres: fellow travellers and Zulus paid by the taxpayers!
- 5. Zululand was given to the Zulus in 1879 and there were 13 Chiefdoms under the King Cetswayo.
- 6. The Department of Cogta increased this to a House of Traditional Leaders with more than 300.
- 7. South Africa is at war and it is led by more than 300 Zulu Leaders and almost 300 other Indunas.

#### SOUTH AFRICA: THAT SUMMARY OF FINDINGS: THE S.W.O.T. ANALYISIS ON THIS SITUATION IN 2022!

- **1.** South Africa is a Covenant Christian Country with 80% Christian majority and 75 865 churches.
- 2. The South African and World Council of Churches supported this Babylonian Empire at Codesa.
- **3.** The White minority were deceived at Referendum in 1992: and promised The Freedom Charter.
- 4. South Africa is country of more than 28 nations that have all been ignored by Cogta: since 1994.
- 5. The Khoi San and Boer Nations have been marginalised: polarised and excluded: from all issues.
- 6. The South African Churches and business chambers have remained silent and irrelevant to this.
- 7. South Africa is a country of many races: cultures: nations and people of different backgrounds.

The ANC established the Moral Regeneration Movement in 1997 - and only launched it in May of 2008.

- **1.** South Africa is part of the 15 SADC groups of countries and this ANC signed the SADC Protocol.
- 2. The Law Association of SADC signed the 2001 Protocol on Corruption but it never did anything.
- 3. The SADCLA Protocols were ratified and also further endorsed in 2014 and the ANC did nothing.
- 4. South Africa is part of the 15 SADC groups of countries and this ANC has not dealt with disease!
- 5. The Christian Lawyers and business leaders and nations all need to deal with an African disease.
- 6. The SADCLA Protocols are the Protocol on Corruption and The Church needs to take that lead.
- 7. South Africa is part of the 15 SADC groups of countries and this ANC will be held accountable!

The ANC established the Zondo Commission in 2018 - and also Anti-Corruption Tribunal in July of 2019.

- **1.** The SADC Protocol demands Corrective Justice and it is based on the Law of Unjust Enrichment.
- 2. Lawyers in South Africa play Devil's Advocate in a justice system that is based on Maritime Law!
- **3.** The ANC has captured this justice and judicial system and have provided immunity for cadres.
- 4. The SADC Protocol demands collaborative Justice and yet justice has been delayed and denied.
- 5. Christian Lawyers and businessmen and nations also need to deal with this corruption in SADC.
- 6. The ANC has provided immunity from prosecution for acts: omissions and actions of all cadres.
- 7. The SADC Protocol demands justice system that prosecutes predators: parasites and presidents.

The ANC established the Cogta Traditional Council Instruction Note – TCIN 03/2017 – and it is relevant!

- **1.** South Africa has more than 28 nations in our country that are all protected by The Constitution.
- 2. The Budget Management Plan for all Traditional Councils mainly includes the Zulus: and Xhosas.
- **3.** The ANC all have a National Democratic Revolution and Radical Economic Transformation plans.
- 4. South Africa has a government that wants Expropriation without Compensations for the blacks.
- 5. The Budget Management Plan for Traditional Councils is not for blacks in particular or general!
- 6. The ANC have a misguided Utopian Dream that is based on The Constitution and we will use it.
- 7. South Africa has the 1996 Constitution that is used to establish all of these Traditional Councils.

The ANC established The Zulu House of Traditional Leadership - all based on a Republic of South Africa.

- **1.** It is based on Act 108 of 1996 and Chapter 12 and Section 211 also provides that recognition.
- 2. It all calls for customary laws to be applied: and even provide those roles those leaders all play.
- **3.** It is based on the Traditional Leadership Act 5 of 2005 and Chapter 2 Section 8 provides this.
- 4. Chapter 2 Section 8 provides functions and roles: and even provides a Budget for that support.
- 5. Chapter 2 Section 11 provides guidelines for support from government and all municipalities.
- 6. Traditional Councils are provided the latitude of using customary laws in that need for justice.
- 7. The Zulu Monarch and a House of 300 Traditional leaders are using customary laws in regions.

The ANC established that Zulu Monarch and a House of Traditional Leadership - and there is no PEACE!

#### THE NATIONAL PEACE COMMISSION: THE NATIONAL PEACE ACCORD: A SECOND HOUSE OF COGTA!

- **1.** The **S.W.O.T** Analysis serves as the guide to leadership on the State of the Nation or a situation.
- 2. The Christian Coalition has done these since 1996: and it gave an ideal understanding of a crisis.
- 3. The South African Christian Chamber of Business was established in July 2019 out of real need.
- 4. The **S.W.O.T** Analysis provides leadership with all research in order to plan and to also prepare.
- 5. The National Peace Commission was established in October 2019 out of a real need for a plan.
- 6. The Christian majority and business chambers most certainly had no action plan: or a blueprint.
- 7. The S.W.O.T Analysis dictates the strategy to be used by leadership to achieve common vision.

The S.W.O.T Analysis is useless if an enemy is not known and there is no Museum of Truth or evidence!

- 1. South Africa needs leadership that at least agrees on the common enemy and knows the threat.
- 2. The 13 Principles of the Art of War are extremely clear: and it is to win the battle without a war!
- 3. The 4 Presidents in South Africa have also embraced that Agenda 21 and Agenda 2030 in 1990.
- 4. South Africa needs leadership that at least understands what this means to a Christian Country!
- 5. All 10 Biblical Principles for Peace and Freedom are extremely clear for Godly Civil Government.
- 6. The 4 Presidents in South Africa have also embraced The Communist Manifesto back into 1990.
- 7. South Africa needs leadership that at least realise what God wants and what our country needs.

The **S.W.O.T** Analysis is pointless if all local dynamics and history are not understood: by all the leaders.

- **1.** The **S.W.O.T** Analysis since 1996 has guided our every step in journey of learning and discovery.
- 2. Nelson Mandela gave us Communism: Abortion: Affirmative Action: and this SACP Government.
- 3. Thabo Mbeki gave us open borders: 550 squatter camps in KZN alone and destruction of SADF.
- 4. The S.W.O.T Analysis since 1998 has guided our research and careful planning for this country.
- 5. Thabo Mbeki gave us persecution of The Church: and closure of The Ark by Durban City Council.
- 6. Jacob Zuma was the one that gave us that Zulu and EFF UHURU Freedom militia from 2008.
- 7. The S.W.O.T Analysis since 2009 has guided our patient preparation after Marikana Massacre!

- 5. They need to understand this is both a Political and Legal or man-made law war we do face!
- 6. This means that there needs to be TWO fronts: where both The Church and all nations are in it!
- 7. South Africa needs leadership that fully understand that importance of obedience to His Laws.

The S.W.O.T Analysis is needs and purpose-driven and is God-Honouring and Kingdom Building in 2022.

- 1. The S.W.O.T Analysis has provided Holy-Spirit Wisdom and an understanding of the Will of God.
- 2. It has exposed the enemy: and provided us with that Museum of Truth and Library of Evidence.
- 3. It has revealed that it is either The Law of Almighty God or it will be His Wrath upon this nation.
- 4. The S.W.O.T Analysis has provided a Biblical Blueprint National Action Plan and a Battle Plan.
- 5. It has provided a process and framework for change and reformation and a very clear direction.
- 6. It has revealed that it is either a National Peace Accord and justice or a total loss of all freedom.
- 7. The S.W.O.T Analysis has provided a Biblical and practical solution to a legal and political crisis.

The **S.W.O.T** Analysis is the foundation of all the work that has been done and is central to what we do!

#### THE SADC TRIBUNAL FOR NATURAL JUSTICE: THE SECOND HOUSE OF COGTA: FREE ZUMA CAMPAIGN

- 1. South Africa has been plagued by wars: communist expansion: corruption: and all this tribalism!
- 2. In 2008 and 2015 the country was torn apart by a tribal unrest: politics of hate and xenophobia.
- 3. It led us to the Zulu Monarch in 2015 after he was accused by Edward Zuma of inciting violence.
- 4. South Africa has been torn apart by intolerance to others: tribal revenge: and Zulu involvement.
- 5. In July 2021 this country was torn apart by the Free Zuma Campaign and all 350 lives were lost.
- 6. It led us back to the Zulu Monarch and House of Traditional Leaders and silence was deafening!
- 7. South Africa has been 'devastated' and more than R70 billion in damages and losses was seen.

South Africa witnessed tribalism or influence of Zulus and Jacob Zuma and failure to protect economy!

- 1. The Free Zuma Campaign was The Tipping Point for the ANC and the Zulu Monarch in July 2021.
- 2. It simply confirmed our research and exposed that influence of the ANC over the Zulu Monarch.
- 3. In May 2015 King Goodwill Zwellitini revealed the Zulu Nation was reliant on that ANC Regime.
- 4. The Free Zuma Campaign was The Tipping Point for the SACP and Department of Cogta in 2021.
- 5. It simply confirmed our careful planning and patient preparation waiting for that perfect time.
- 6. In May 2019 King Goodwill Zwellitini revealed the desperate need for a National Peace Accord.
- 7. The Free Zuma Campaign was The Tipping Point for this President and Cabinet of 28 Ministers.

South Africa witnessed the silence of a Zulu Monarch and also the House of all 300 Traditional Leaders!

- **1.** South Africa has a Babylonian Empire that relies on that Communism: Tribalism and Corruption.
- 2. It has captured the Judiciary and Justice System: and has immunity from prosecution for cadres!
- **3.** It has centralised control in Luthuli House where a SACP Shadow Government provide policies.
- 4. South Africa has a Babylonian Justice System: that relies on a cadre deployment for their judges.
- 5. It has captured the Legislature the law-making body and it takes all instructions from SACP!
- 6. It has centralised control of all organs of State and the Department of Cogta enforces all policy.

- 7. The ANC and their cadres have relied on Shipping Laws and Laws of the Sea for their defence!

South Africa witnessed the Marikana Mine Massacre in August 2012: and Free Zuma Campaign in 2021!

- **1.** South Africa has a Babylonian Court System that has been established: to protect the parasites.
- 2. It is a war that has been declared on the people: economy: The Church and all the food security.
- **3.** South Africa can rely on Natural Law that is used in order to protect: defend and also contend.

- **1.** King Goodwill Zwellitini was the Zulu Monarch who was used by the ANC for the past 27 years.
- 2. He was used by these past 4 presidents to achieve their global and national political objectives.
- **3.** He was aware of the plans to destroy the economy and established the House of 300 leaders.
- 4. King Goodwill Zwellitini was the Zulu Monarch who was also the descendant of King Cetswayo.
- 5. He was used by the 4 presidents and Department of Cogta to be custodian of Ingonyama Land.
- 6. He was aware of their plans to destabilise the country and established those 3 000 Izindunas.
- 7. King Goodwill Zwellitini was that Zulu Monarch who received more than R200 million a year!

The King Cetswayo and only 13 Chiefdoms received that land of Zululand in 1879 - from British Crown!

- 1. Cyril Ramaphosa and Jacob Zuma orchestrated and planned that Free Zuma Campaign in 2021.
- 2. King Goodwill Zwellitini understood the consequences of this planned destruction of economy.
- 3. His son was murdered in 2020 and he died: supposedly after some complications with Covid 19.
- **4.** Cyril Ramaphosa and Jacob Zuma were responsible for the deaths and destruction: in July 2021.
- 5. They neither protected lives: property or the economy in the 9 days of plundering and killings.
- 6. King Goodwill Zwellitini understood the consequences of this planned food security destruction.
- 7. Cyril Ramaphosa and Jacob Zuma and his family members instigated those orchestrated actions.

The King Goodwill Zwellitini and House of 300 Traditional Leaders received land and money from ANC!

- **1.** King Goodwill Zwellitini had requested a National Peace Accord to be developed by this writer.
- 2. He was a man of Peace and a Christian and wanted to put an end to the lawlessness and crime.
- **3.** He was concerned about the increasing poverty: corruption and all the politics of hate in 2015.
- 4. King Goodwill Zwellitini had requested a National Peace Accord that demanded all that justice.
- 5. He was concerned about the increasing xenophobia and he wanted restorative justice in 2019.
- 6. He was concerned about the loss of food security and explained customary laws that existed.
- 7. King Goodwill Zwellitini had requested that a National Peace Accord be used to unite nations!

The King Goodwill Zwellitini and House of 300 Traditional Leaders received taxpayers land and money!

- **1.** Cyril Ramaphosa and Jacob Zuma did not support the concerns of the Zulu Monarch in 2020!
- 2. The King of the Zulus wanted Peace and Prince Buthelezi attended the launch of Peace Accord.
- 3. In March 2019 the Prime Minister of the Zulu Nation attended the meeting for a Peace Accord.
- 4. Cyril Ramaphosa and Jacob Zuma did not want peace: or a stable economy in all South Africa.
- 5. In March 2019 at the William Carey World Missions National Peace Commission was launched.
- 6. In May 2019 the National Peace Accord was all ready to be signed by King Goodwill Zwellitini.
- 7. Cyril Ramaphosa and Jacob Zuma did not want socio-economic growth and development at all.

King Goodwill Zwellitini and House of 300 Traditional leaders wanted an end to the corruption in 2019.

- **1.** King Goodwill Zwellitini requested The Second House of Cogta be established for all the nations.
- 2. He wanted Biblical Principles and food security and a vibrant economy for the people in all KZN.
- 3. He wanted agricultural development: socio-economic growth: and also the investor confidence.
- 4. King Goodwill Zwellitini requested the Business Chambers to participate in this new framework.
- 5. He wanted The Church and other religious groups to participate in this call for a united nations.
- 6. He wanted an end to the corruption and agreed to use customary law and that House of Cogta.
- 7. King Goodwill Zwellitini requested the SADC Protocols be used to deal with all that corruption.

King Goodwill Zwellitini and House of 300 Traditional Leaders wanted a SADC Court of Natural Justice!

### THE SADC TRIBUNAL FOR NATURAL JUSTICE: THE NATIONAL PEACE ACCORD: AND A BIBLICAL LAW!

- 1. The ANC Political Party and its cadres in Luthuli House have been immune from all prosecution.
- 2. It has lost its moral compass: all rights and jurisdiction to rule: and has captured the legislature.
- **3.** It has declared war on the people with military lockdowns: house arrest and all police brutality.
- 4. The ANC Political Party and its cadres in Luthuli House have committed crime against humanity.
- 5. It has not built or protects an economy and has declared war on The Church and food security.
- 6. It has declared war on the farmers and established more than 550 squatter camps in all of KZN.
- 7. The ANC Political Party and its cadres in Luthuli House ignored global warning and cries of poor.

The declaration of war on people provides that Natural Law - or Right to protect: defend and contend!

- **1.** The National Peace Commission was established as a Moral Regeneration Movement in 2019.
- 2. The Second House of Cogta and Voice of Public Opinion was required and unity in the nations.
- 3. South Africa needs a Coalition on Moral Revival and also a Voice of Truth: Reason and Wisdom.
- 4. The National Peace Commission was established out of a desperate need for all that freedom.
- 5. The Second House in Government was required and unity in The Church always brings peace.
- 6. South Africa needs a Coalition on Moral Revival and Truth: Justice and Righteousness in 2022.
- 7. The National Peace Commission was established to ensure there is also a moral government!

The declaration of war on the poor provides that Biblical Law – and it is a Perfect Divine Law above all!

- **1.** The ANC Political Party and cadres in Luthuli House have relied on a Maritime or Admiralty law.
- 2. It no longer has authority to lead or manage country and has ignored all other laws in the land.
- 3. It has ignored Biblical Laws and Commands If you love Me obey My commands John 14:15.
- **4.** The ANC Political Party and cadres in Luthuli House has relied on cadre deployment for safety.
- 5. It has ignored that need to *maintain a justice in the courts and righteousness Amos 5:15-24*.
- 6. It has also ignored the Biblical Principles and definitions that all *sin is lawlessness* 1John 3:4.
- 7. The ANC Political Party and cadres in Luthuli House has relied on corrupt judges for security!

The declaration of war on The Church and a desecration of churches provides for a Perfect Divine Law!

- 1. The National Peace Commission understands Civil Government is under God as in John 19:11.
- 2. It must uphold Biblical Law and these commands and guides are all in Matthew and 5:17-19.
- **3.** It has a limited Jurisdiction and very few rights and responsibilities and it is in *1Peter 2:13-14*.
- **4.** The National Peace Commission understands Civil Government must serve in *Luke 22:25-26*.
- 5. It must uphold the Sanctity of Life and even the unborn *Genesis 9:6* and *Exodus 21:12-16*.
- 6. It is only Biblical Principles that the Lord is our Judge *Isaiah 33:22* and in *2 Chronicles 19:5-7*.
- 7. The National Peace Commission understand Civil Government must be capable *Exodus 18:21*.

The declaration of war on The Church and destruction of homeless shelters provides for all of His Laws.

- **1.** The National Peace Commission was supported by the Zulu Monarch and a Zulu Prime Minister.
- 2. It is also supported by Africa Christian Action: Christian Action Network: a Christian Lawyers Ass.
- **3.** Christian Liberty Books: Christians for Truth International: Coalition on Revival: Doctors for Life.
- 4. It is also supported by Focus on the Family Africa: Frontline Fellowship: and The Joy Magazine.
- 5. Gospel Defence League: a KwaSizabantu Mission: Reformation 500 FIRE: and Summit Ministries.
- 6. It is also supported by The William Carey World Missions: The Theocentric Christian Education.
- 7. The National Peace Commission is supported by The Reformation Society and so many others.

The declaration of war has opened up the door for the war on Communism: Tribalism: and Corruption!

#### THE NATIONAL PEACE ACCORD: UNITING THE CHURCH: THE LIVING CROSS CRUSADE: IT IS THE TIME!

- 1. The Church an 80% Christian majority has remained silent on this Genocide since April 2020.
- 2. It has remained silent on abortion and corruption and all farm killings since they began in 2001.
- **3.** It has remained indifferent to all this Agenda 21 and Agenda 2030 and also **The Great Reset**.
- 4. The Church and more than 75 865 churches has remained tolerant to all this politics of hate!
- 5. It has remained apathetic and indifferent to the destruction of The Ark Ministries in May 2004.
- 6. It has remained ignorant or in denial over the Covid 19 gene therapy experimental programme.
- 7. The Church and more than 300 different denominations is silent to a Free Zuma Campaign!

The Church must take the lead in all this moral regeneration and this coalition on moral revival in 2022!

- 1. The Church must actively participate in this SADC Tribunal for Natural Justice: and it must unite!
- 2. This is a wakeup call for Christian Lawyers and that SADC Protocol to put an end to corruption.
- 3. It is time to take back authority in the Justice System: and also reclaim that surrendered ground.
- 4. The Church must actively participate in all the National expansion of the SADC Tribunal: in 2022.
- 5. This is a wakeup call for all Gods Advocates and take over the responsibility from those SADCLA.
- 6. It is time that the SADC Lawyers Association is relieved of their mandate to fight all corruption.
- 7. The Church must actively participate in this war against Communism: Tribalism and Corruption!

The Church must take the lead in this SADC Protocol that is a 2001 Protocol to fight all that Corruption!

- **1.** The National Peace Commission met with the Law and Religious Communities in January 2020.
- 2. Delegates from these SADC Countries: Europe: United Kingdom and other countries met at this.
- 3. On January 19-22 in 2020 we met in Durban to discuss all of these challenges facing The Church.
- 4. The National Peace Commission met with ACLARS African Consortium for Law and Studies and
- 5. WARCLAR Western African Consortium for Law and Religious Studies and also that BYULAW –
- 6. The International Centre for Law and Religious Studies and The Church needs to seek justice!
- 7. The National Peace Commission will no longer tolerate the persecution or war on The Church!

The Church must take the lead in this Living Cross Crusade to ensure that there is no more persecution!

- 1. South Africa must take the lead in this SADC Tribunal for Natural Justice and not delay in 2022!
- **2.** The very first tribunal will be held in Durban and it will comprise of a Council of 28: with 7 Laws.
- **3.** These all include Natural Law: Common Law: Communal Law: Foreign Law and Aboriginal Law.
- 4. The very first tribunal will be held and will also include Labour Law and the Perfect Divine Law!
- 5. These 7 Laws will be utilised to deal with the 7 Protocols that have also destroyed this country.
- 6. These all include Communism and Tribalism: Corruption: Centralised Controls: Corporation: and
- 7. South Africa must deal with Cadre Deployment: Captured Judiciary: and Persecution of Church!

The Church and all the Nations of South Africa will witness history being made in a new Judicial System!

- **1.** South Africa needs hope: help and healing and peace and freedom from despotic rule in 2022.
- 2. No presidents: premiers: or public servants or cadres will be immune from new justice system!
- **3.** The very first tribunal will lay the foundation for Foreign Law and will embrace SADC Protocols.
- **4.** South Africa needs accountability: transparency: collaborative: corrective or restorative justice.
- 5. The very first tribunal will lay the foundation for 275 municipalities and all 15 SADC Countries.
- 6. There are four cases and include the Claim of R528 million for a destroyed Church in May 2004.
- 7. It includes a Claim for R200 million in the Free Zuma Campaign and another for R950 million!
