INTRODUCTION: THE NATIONAL PEACE COMMISSION: THE SADC TRIBUNAL FOR NATURAL JUSTICE

1. The National Peace Commission was established in March 2019 as the Voice of Public Opinion.
2. It was established in terms of the requirements established by 1991 UN: the EU: and that OAU.
3. It was established on the same basis that it is needs and purpose-driven to resolve all disputes.
4. The National Peace Commission was established in March 2019: by the Council of 28 Members.
5. It was established by The Christian Coalition that is a registered Moral Regeneration Movement.
6. It was also established with the full support of The South African Christian Chamber of Business.
7. The National Peace Commission was established in March 2019: for the purposes of true peace.

The Christian Coalition was established in 1996 – and registered in 2008 with number **2008/025179/08**.

1. The National Peace Commission was established - to provide a platform for dispute resolutions.
2. It was established at the request of the Zulu Monarch – *King Goodwill Zwelitini*: in May of 2015.
3. It was established at a special request of the Department of Justice in Cape Town - in June 2015.
4. The National Peace Commission was established – to provide a solution - to increasing violence.
5. It was established at the request of The Church – and an 80% Christian majority in May of 2019.
6. It was established at the special request of all Business Chambers and corporate sector in 2019.
7. The National Peace Commission was established in March 2019: for the purposes of true peace.

The South African Christian Chamber of Business was established in 2019: as number **2019/292598/07**.

1. The National Peace Commission was established for all the same reasons as those back in 1991.
2. The tribal and political unrest had reached a stage where intervention was required - for peace.
3. There are more than 550 informal settlements in Kwa Zulu-Natal alone - and increased poverty.
4. The National Peace Commission was established because we have Junk Status and a Recession.
5. The Zondo Commission and Anti-Corruption Tribunal had failed to prosecute all public servants.
6. The Durban City Council had destroyed a 900-bed homeless shelter: and there was persecution.
7. The National Peace Commission was established because there was corruption - **and no justice!**

The National Peace Commission was established because there was a need for true justice - and peace!



THE PRIMARY AIM OF SADC TRIBUNAL FOR NATURAL JUSTICE - **PUBLIC SERVANT ACCOUNTABILITY!**

1. The National Peace Commission was established in March 2019 to provide peaceful resolutions.
2. More than 28 years of meticulous research has provided invaluable research into all challenges.
3. More than 13 years of community engagement in public and private sectors has supported this.
4. The National Peace Commission was established in October 2019 as The Second House to do it.
5. More than 7 years of informal and formal sector participations: has justified the establishments.
6. More than 2 years of military lockdowns: house arrests: and closure of economy: has justified it.
7. The National Peace Commission was established in October 2019 to bring peace to our country.

The Anti-Corruption Tribunal was approached in November of 2019 - and was ignored by management!

1. The National Peace Commission sent a Letter to Office of President in April 2020: with requests.
2. It was a Final Demand for all Accountability sent by *Luthuli Attorneys* with specific requirement.
3. It was in response to the Closure of the Economy and the churches by the Department of Cogta.
4. The Requests were specific and reasonable and were related to the Covid 19 Lockdown in 2020.
5. It was a Final Demand and reminded the Office of President of that need for Batho Pele Service.
6. It was in in response to the failure of this Government to uphold 11 1997 Batho Pele Principles!
7. The National Peace Commission reminded the Office of the President - of need for consultation.

The Office of the President acknowledged receipt of Letter - but ignored that request for explanations!

1. The request included all the Summary of all Findings of that R1 billion 2018 Zondo Commission.
2. It included the Summary of Findings of Anti-Corruption Tribunal that refused to be transparent.
3. It also included the Summary of Findings of a Covid 19 Corona Virus and justification for action.
4. It included that Summary of Findings on the Chinese Trade Agreements - and that relationship.
5. It also included the Summary of Findings on the World Bank Loans: and obligations to contract.
6. It included the Summary of Findings on the World Health Organisation Partners: and contracts.
7. The requests were all ignored by this President and his Cabinet of 28 Ministers in April of 2020.

The Office of the President refused to respond to the respectful request for that Summary of Findings!

1. The National Peace Commission also sent another 17-Page Letter to the Office of the President.
2. In June 2020 that Office of this President and his Cabinet of 28 Ministers - were sent this Letter.
3. It was a Final Demand from The Church and Civil Society demanding accountability and actions.
4. It was sent in Terms of *Section 3 of the Institution of Legal Proceedings against Organs of State*.
5. The National Peace Commission had notified them of that Ethics Committee - that was in place.
6. In June 2020 that Office of this President and his Cabinet of 28 Ministers – were given a **Notice!**
7. It was sent through Luthuli Attorneys and it was entered into the public domain for comments.

The Office of the President refused to respond to the Notice and Final Demand: for that accountability.

1. The National Peace Commission identified the 28 Cabinet Ministers and provided all the names.
2. President Cyril Ramaphosa: 2. Deputy President: David Mabuza: 3. Thoka Didiza: 4. and Ronald Lamola: 5. Bheki Cele: 6. Lindiwe Sisulu: 7. Thulas Nxesi: 8. Senzo Mchunu: 9. Barbara Creecy: 10. Angie Motshekga: 11. Aaron Motsoaledi: 12. Nathi Mthetwa: 13. And one Maite Nkoane-Mashabane: 14. Patricia De Lille: 15. Jackson Mthembu: 16. Tito Mboweni: 17. Zweli Mkhize: 18. Blade Nzimande: 19. THE SUMMARY OF THE LETTER: THE NOTICE TO PROCEED: AND NEED FOR ACCOUNTABILITY IN 2020

1. The Notice to the Office of the President and a Cabinet of 28 Ministers was from all the People!
2. It highlighted the need for all Batho Pele-People First- Principles and the lack of all consultation.
3. It demonstrated the lack of jurisdiction: authority and service delivery in terms of the Principles.
4. The Notice to the Office of the President and Cabinet of 28 Ministers provided acts – omissions!
5. It highlighted the need for Freedom of Religion and that actual role of a CRL Rights Commission.
6. It demonstrated the lack of political will to deal with that corruption - and the levels of controls.
7. The Notice to the Office of the President and Cabinet of 28 Ministers provided all that evidence.

The Office of the President and Cabinet of 28 Cabinet Ministers chose to ignore the warnings - in 2020.

1. The Notice to the Office of the President and a Cabinet of 28 Ministers was about the economy.
2. It addressed speech of Minister of Economic Development: Tourism: and Environmental Affairs.
3. It questioned the reasoning of the Minister – *Nomusa Dube-Ncube* – and all her public address:
4. The Priority areas were given as: 1. Access to Finance: 2. Lack of Funding and 3. Job all Creation.
5. 4. Poverty Relief: 5. Food Security: 6. Removing Barriers: 7. Obstacles - and 8. Black Businesses.
6. It questioned that reasoning of the Minister - to request assistance in giving her Budget Speech.
7. The Notice to the Office of the President and Cabinet of 28 Ministers was justified in that time!

The Office of the President and Cabinet of 28 Ministers chose to declare the war on economy - in 2020.

1. The Notice to the Office of the President and Cabinet of 28 Ministers questioned the reasoning.
2. It was a Notice after the initial Letter sent on the 28th of April 2020 and requested all the clarity.
3. It questioned the abuse of power of the SAPS and SADF in incidents of arrests and prosecutions.
4. The Priority areas were given as the high levels of corruption and the failure to provide security.
5. It questioned the lack of food security - and desperate need for socio-economic growth in 2020.
6. The issue of 550 informal settlements and lack of poverty relief were presented in this warning.
7. The Notice to the Office of the President and Cabinet of 28 Ministers was relevant in that time!

The Office of the President and Cabinet of 28 Ministers chose to declare war on food security - in 2020!

1. The Notice to the Office of the President and his Cabinet of 28 Ministers carried a clear warning.
2. The Government of South Africa had appointed a National Command Council - of only 6 people.
3. It was led by Minister *MEC Dlamini Zuma* as Department of Cogta - without that legal authority.
4. In terms of the *Disaster Management Act 57 of 2002* she did not have the Authority to do that!
5. It was done without any **Constitutional Mandate** - or approval of Parliament or their Oversight.
6. The Priority areas were that severe Constitutional Dictates had been violated: and it is unlawful!
7. The Notice to the Office of that President and Cabinet of 28 Ministers was based on legal rights!

The Office of the President and Cabinet of 28 Cabinet Ministers chose to ignore Constitution: and Laws!

1. The Notice to the Office of that President and his Cabinet of 28 Ministers was about corruption.
2. The Government of South Africa had also been responsible for that loss of more than R3 trillion.
3. It was led by President *Jacob Zuma* and *Cyril Ramaphosa* since 2009 and was taxpayer's money.
4. *Section 146(6)* of The Constitution is clear on public trust and also an abuse of entrusted power.
5. The Priority areas were that there were no investigations: or prosecution: or restorative justice.
6. It was clear that this Government has no political will and is above the law and even rule of law.
7. The Notice to the Office of the President and Cabinet of 28 Ministers is about that Foreign Law!

The Office of the President and Cabinet of 28 Cabinet Ministers all chose to ignore the SADC Protocols!

THE HISTORY OF CORRUPTION: UNJUST ENRICHMENT: AND THE PLUNDERING OF THE PUBLIC PURSE!

1. The Notice to the Office of President and 28 Cabinet Ministers is based on *State Act 40 of 2002*.
2. It clearly notified them that we are a National Peace Commission - dealing in dispute resolution.
3. It was clear that The Second House was required to mediate: arbitrate and resolve these issues.
4. The Notice to the Office of President and 28 Cabinet Ministers is based on that SADC Protocols.
5. In 2001 the South African Government signed a SADC Protocol against Corruption in Zimbabwe.
6. It further ratified this commitment to fight corruption in 2014 but has done nothing to end this.
7. The Notice to the Office of President and 28 Cabinet Ministers is based on **Unjust Enrichment!**

The Office of the President and the Cabinet of 28 Ministers all chose to ignore what is this Foreign Law.

1. The Notice to the Office of President and 28 Cabinet Ministers is based on *Batho Pele Principles*.
2. It demands Consultation: Cooperation: Collaboration - and Collaborative and Collective Justice.
3. All efforts to act as an oversight to that Zondo and Anti-Corruption Tribunal were also ignored.
4. The Notice to the Office of President and 28 Cabinet Ministers is based on *Moral Regeneration*.
5. It demands that Consultation with that *Moral Regeneration Movement* started by ANC in 2008.
6. All efforts to act as an official Peace Commission as started by an ANC at Codesa in 1991 failed.
7. The Notice to the Office of President and 28 Cabinet Ministers - is based on that initial process!

The Office of the President and Cabinet of 28 Ministers all chose to ignore what is Peace Commissions.

1. The Notice to the Office of President and 28 Cabinet Ministers - is based on a *Museum of Truth*.
2. It is The Second House of Cogta - and wants a Cooperative Governance in all Traditional Affairs.
3. It has a *Library of Evidence* and demands the consultation and accountability: on many matters.
4. The Notice to the Office of President and 28 Cabinet Ministers is based on meticulous research.
5. It has relied on The Daily Tabloids: Daily Maverick Score Card on Ministers: and Auditor General.
6. It is The Second House of Cogta – and wants collaborative justice - and audits on municipalities.
7. The Notice to the Office of President and 28 Cabinet Ministers is based on that need for justice.

The Office of the President and Cabinet of 28 Ministers all chose to ignore what is all People Warnings!

1. The multi-billion Rand Arms deal in the 1990's: the Road Accident Fund: and a Manase Report.
2. The Land Reforms Scandals: Ingonyama Trust Land Scandals: and also the Gupta State Capture.
3. The 2010 Fifa World Cup Scandal: Wastage of R68 Billion: and the VBS Bank Scandal in Limpopo.
4. The 275 Municipalities in distress: Destruction of 701 State-managed Enterprises: Eskom Crime.
5. The RDP Housing Scandals: The Municipal Supply Chain Management: and all Catalytic Projects.
6. The Destruction of Homeless Shelters - in Durban: Persecution of Churches: Cadre Deployment.
7. The War on Food security: Opening of Borders: Squatter Camp Development: War on Economy.

The Office of President and Cabinet of 28 Ministers chose to ignore what is also clear Global Warnings!

5. The Global Institute for Freedom of Religion and Political Studies was ignored - for **persecution!**
6. The Global or SADC Countries Law Association and SADC Protocol were ignored for **corruption!**
7. The Global or SADC Countries Tribunal for Natural Justice was all ignored and it brings **JUSTICE!**

The Office of President and Cabinet of 28 Ministers chose to ignore what is also clear Justice Warnings!

1. The Office of a President and Cabinet of 28 Ministers did not heed the Global Warnings in 2020.

7. The SADC Tribunal for Natural Justice seeks that Ten Biblical Principles for Peace and Freedom!

The SADC Tribunal for Natural Justice will prosecute all public servants and cadres: for that corruption!

1. The SADC Tribunal for Natural Justice seeks Restorative Justice and relies on all the Biblical Law.
2. It also seeks Corrective Justice and relies on Foreign Law and where there is Unjust Enrichment.
3. It is also contained in the 16-Page SADC Protocol that allows for all prosecution - and forfeiture.

7. The SADC Tribunal for Natural Justice relies on The Church and that Coalition on Moral Revival!

The SADC Tribunal for Natural Justice will prosecute all those internal and external enemies - **of Peace!**

THE NATIONAL PEACE COMMISSION: THE HISTORY OF PEACE COMMISSIONS - IN SOUTH AFRICA!

1. Peace Commissions or Committees are formal and officially supported or informal in structure.
2. They are grassroots derived structures at a national: regional and local levels and needs-driven.
3. They are established to involve community members in resolving issues - through joint actions.
4. Peace Commissions or Councils are established for the purpose of reducing conflict - or unrest.
5. They are established to reduce: counter or prevent conflict by involving communities to do this.
6. They are grassroots movements to promote human rights: and to promote the social cohesion.
7. Peace Commissions provide leadership and advocacy - to promote racial and cultural cohesion.

The National Peace Commission was established in Kwa Zulu-Natal in 2019 to achieve these objectives.

1. Peace Commissions can assist to help contain political or tribal violence by identifying all threat.
2. They can be set up on a top-down or bottom-up approach and can be set up at a national level.
3. They are a special purpose vehicle that can be utilised to promote moral regeneration - or unity.
4. Peace Commissions can be highly successful in the event they are supported by external actors.
5. They can include paid and volunteer members and include outside funders and support groups.
6. They must be respected in communities and represent all religious: ethnic and cultural entities.
7. Peace Commissions have been used successfully to bring economic certainty - and that stability.

The National Peace Commission was established in Kwa Zulu-Natal in 2019 - to reduce the lawlessness.

1. Peace Commissions are essential to anticipate conflict: and then resolve the disputes timeously.
2. Generally members live under the same conditions as the people they serve: and understand it.
3. They are not distanced from the conflict but rather connected to and trusted by those partners.
4. Peace Commissions are often made up of lay church leaders or clergy and help sustain progress.
5. Not all members must be professional mediators: or formally trained in conflict resolution skills.
6. They need to be made up of at least one technical assistant: and groups must select leadership.
7. Peace Commissions are important to study: investigate and mediate - in public hearing events.

The National Peace Commission was established in Kwa Zulu-Natal in 2019 – to reduce that corruption.

1. Peace Commissions are comparatively low-cost - and extremely cost-effective - if managed well.
2. Funding can come from government: bilateral government organisations and agencies or NGOs.
3. This South African experience suggests that commissions should be funded from other sources.
4. Peace Commissions can be funded from churches: and from both inside and out of the country.
5. Funding produces interventions with immediate results - and this includes strikes: and violence.
6. This South African experience suggests that both parties must have a commitment to the peace.
7. Peace Commissions that are informal do not require any form of official agreement to operate.

The National Peace Commission was established in Kwa Zulu-Natal in 2019 – to reduce the persecution.

1. Peace Commissions were established as Dispute Resolution Commissions: in the period of 1991.
2. Intention was to establish nationwide network: of what became known as Peace Commissions.
3. A National Peace Secretariat (NPS) is permanent: and full-time consisting of only 7 to manage it.
4. Peace Commissions were established with the support of the Justice Department in that period.
5. A National Peace Commission can be comprised of any number of people: and even up to sixty.
6. Intention was to facilitate hundreds of disputes in 1993: but was not supported by new regime.
7. Peace Commissions were established to prevent a conflict and violence that was being created.

The National Peace Commission was established in Kwa Zulu-Natal in 2019 – **to eliminate the problem!**

THE SADC TRIBUNAL FOR NATURAL JUSTICE: THE SUMMARY OF FINDINGS: AND THIS JUDGEMENT!

1. South Africa has a humanitarian and economic crisis in 2022 and the cause of this is also known.
2. The challenge facing concerned interest groups lies in the ability to accept the harsh reality of it.
