

The WHO's new treaty makes it a dictator

It is extremely heartening and encouraging to learn that MPs in the UK, US and in Australia are calling for their respective governments to refuse to sign the treaty that will give the WHO authoritarian powers, over sovereign states, to declare emergencies, impose lockdowns and become the arbiters of misinformation.

The WHO, in its typical style, used a number of euphemisms like "agreements", "accord" and "recommendations" to placate/dupe opponents of its devious plan to convert the world body from a health advisor to an authoritative organisation.

The WHO was created in 1946, after WW2, to act in an advisory capacity to member states to deal with serious health issues.

The current amendments are nothing less than a treaty, which binds member states to abide by the decisions made by the head of the WHO. Member states will have little or no recourse for the damages, if the decisions made by the

WHO are completely flawed.

The word "binding" has been incorporated into the WHO document about the amendments, which makes it quite implicit that member states have to follow the decisions of the WHO.

This word, "binding" gives the WHO authoritative powers over sovereign states, which is ominous, given the highly dismal track record of this organisation long before the pandemic and during the pandemic.

The WHO's rationale for being so hasty to push this treaty through is to enable the WHO to be "better prepared for future Pandemics", a phrase that is often used by the non-medically trained vaccine investor, Gates.

We have seen how, Tedros, the fugitive from Ethiopia, exerted his authority and overruled 8 of his scientists and declared the mild monkey pox scourge as a pandemic without an iota of protest from our health regulatory authorities or academics that a handful of self-limiting cases is grossly insufficient to declare a pandemic.

The WHO is guilty of making an absolute mess of Covid.

Some of their major crimes and not mistakes or errors include:

1. the pandemic was declared on unscientific grounds.

At the time when the pandemic was declared, the recovery rate from the original Wuhan strain was 99.9% without much medical intervention.

- The high death rate ascribed to covid in the first year were not properly verified whether the deaths were from Covid or whether Covid was an incidental finding.

2. The WHO failed to acknowledge early treatment as a way to prevent complications and death.

3. They opposed safe and effective repurposed drugs like Ivermectin and Hydroxy Chloroquine to treat Covid

4. They failed to conduct their own research on the safety and efficacy of vaccines.

5. They took very long to advise against the use of Covid vaccines on adolescents due to the risk of myocarditis and the fact that the majority of the world's children did not need vaccines because they had effective natural immunity

6. They never ever mentioned the benefits of natural immunity.
7. Did not heed the advice of one of their investigators, Dr Andrew Hill that the essential, safe and cheap drug Ivermectin could prevent Covid deaths
8. Did not promote the importance of vit D , Vitamin C and zinc to minimise the morbidity caused by the virus
9. they did nothing to stop doctors and hospitals from using the highly costly toxic drug,remdesivir, during the pneumonic phase of Covid illness
10. Did not consider the serious adverse effects of lock-downs on:
 - the economies of many third world countries
 - the negative impact on children's learning, nutritional status, as they were denied access to food through the school feeding schemes.
 - they said nothing about the millions of school going females in Africa that were either forced into early marriage or to work as prostitutes to support their families
11. Totally ignored and still ignores the plight of the vaccine injured
12. They never liased with frontline doctors throughout the

world that discovered methods to treat Covid successfully.

13. They completely ignored the evidence that the vaccines were totally ineffective against the newer strains and variants.

14. They were completely silent when:

- the Pfizer documents revealed that there were 1200 deaths associated with the Vaccine; 1293 side effects
- the FDA, outrageously pleaded to the judge to allow them reveal these documents after 75 years
- there was a 40% increase in excess mortality in the US after the vaccine rollout in 2022
- spike in sudden adult deaths in young healthy sportspeople
- when one of their scientists, Dr Swaminathan was accused by the Indian bar Association for misleading India about the safety of Ivermectin

16. Never once did they accept that natural immunity is far more effective than artificial immunity; it is safer, lasts longer and is free.

17. During the Omicron strain, there were hardly any deaths, yet the WHO persisted in maintaining the pandemic status for almost two years. It should have ended two years ago after the Barrington declaration pointed out that the

lock downs, social distancing and masks were not effective to control the spread and that they caused immense harm to the young and healthy, who were not severely affected by covid.

18. The WHO focussed too much energy and resources on promoting the new untested Vaccines, instead of channeling its resources to combat other diseases like TB, AIDs and malnutrition as well as the negative impact on the lockdowns, which are too many to mention in this article.

The above are just a few failures by the WHO during the contrived Covid crisis that illustrates that the WHO failed society dismally in its hour of need because, it seems, it was pandering to the agenda of its major private funders instead of looking at the wellbeing of society.

Sweden, was one country that did not force lock-downs nor mandate vaccines on their citizens and their death rates amongst children and their citizens through Covid was less than it was for countries like the US, which imposed strict lockdown policies and mandated vaccines.

I applaud the British conservative party MP, Esther McVey

and her six colleagues for opposing the WHO's treaty, which if ratified by member states, will hand over our sovereignty to the totally incompetent and highly compromised WHO.

The WHO is playing God, when it chooses to be the arbiters of information. We have had enough of social media platforms violating our rights to free speech and labelling critical thinkers as conspiracy theorists. It is not science when it cannot be criticised, challenged or questioned for its validity.

The WHO, during this pandemic has fallen from grace following its failure to come to the rescue of society in the last three years.
